## **AIR CONDITIONING - GENERAL** INSTALLATION OF A COVER OVER THE ECS TEMPERATURE CONTROL VALVE

#### **Planning Information** 1.

#### A. **Effectivity**

All PC-12 and PC-12/45 aircraft from MSN 101 up to and including MSN 260.

This Service Bulletin will be incorporated prior to delivery on aircraft MSN 261 and subsequent.

#### B. **Concurrent Requirements**

None

#### C. Reason

#### (1) **Problem**

The temperature control system does not operate correctly in wet conditions.

#### (2) Cause

Rain water can go into the engine compartment at the seals between the left and right upper engine-cowlings and the front pressure bulkhead. The water can collect in the electric actuator of the temperature control valve and cause it to become unservicable.

#### Solution (3)

Install a cover over the top of the temperature control valve to prevent the collection of water.

#### D. **Description**

This Service Bulletin gives the necessary data and instructions to install the new cover over the temperature control valve.

Revision A of this Service Bulletin changes the warranty statement.
