MODIFICATION OF THE HYDRAULIC SERVICE SELECTOR VALVE

1. Planning Information

A. Effectivity

- (1) All aircraft up to and including MSN 180.
- (2) This Service Bulletin will be incorporated prior to delivery on aircraft MSN 181 and subsequent.

B. Reason

One case has been reported where the check valve, located in the Service Selector Valve (SSV), had failed to close fully. After investigation it was found that particle contamination caused the SSV not to seat correctly. This can cause leakage through the valve which will induce frequent cycling of the Hydraulic Pressure Pump (HPP), to maintain system pressure.

This Service Bulletin introduces a filter into the Tee-piece adapter, upstream of the check valve, to prevent particle or foreign object contamination of the check valve.

C. Description

Accomplishment of this Service Bulletin consists of completing the following tasks:

Aircraft

- (1) Remove the special Tee-piece adapter (P/N 946.23.65.370).
- (2) Install the new Tee-piece adapter assembly (P/N 529.13.12.118).

D. Compliance

Highly Recommended.
