LANDING GEAR - NOSE LANDING GEAR MODIFICATION TO SEALS AND BARREL NUT

1. Planning Information

A. Effectivity

- (1) All PC-12 and PC-12/45 aircraft from MSN 101 up to and including MSN 269.
- (2) This Service Bulletin will be incorporated, prior to delivery on aircraft MSN 270 and subsequent.

B. Concurrent Requirements

None.

C. Reason

(1) Problem

The barrel nut of the Nose Landing Gear (NLG) cannot be tightened correctly which can cause internal damage to the NLG seals.

(2) Cause

The barrel nut has a lock plate with set barrel nut positions which do not allow the barrel nut to be fully tightened.

(3) Solution

The NLG lockplate is removed and discarded. Then the barrel nut is tightened to a set torque value and secured with two lock-wires.

D. Description

This Service Bulletin introduces a new procedure to secure the NLG barrel nut.
