This Service Letter is issued to draw attention to the following vendor information:

**PRATT & WHITNEY CANADA SERVICE INFORMATION LETTER (P&WC SIL) NO. PT6A-143 - PT6A-67B FUEL CONTROL BELLOWS REPLACEMENT.**

P&WC SIL No. PT6A-143 is issued to tell all operators that P&WC Service Bulletin (SB) 14371 (Fuel Control Bellows Replacement) has been accomplished on all affected aircraft. But there are 14 Fuel Control Units (FCUs) held as spares that have not been modified. The locations of the 14 FCUs are not known. P&WC SIL No. PT6A-143 lists the serial numbers of the 14 pre SB 14371 FCUs. Operators must check the serial number when a replacement FCU is to be installed to make sure it is post SB 14371.

A Caution has been included in the Engine Maintenance Manual to instruct personnel to check the serial number when a replacement FCU is to be installed.

Pilatus fully supports the content of P&WC SIL No. PT6A-143 as installation of a pre SB 14371 FCU could result in engine failure.

Subject PT6A-67B Fuel Control Bellows Replacement

Applicability PT6A-67B Engines


This Service Information Letter (SIL) is issued to advise all operators that SB 14371 originally issued to replace the Fuel Control Unit (FCU) bellows has now been accomplished on all affected aircraft. We would like to take this opportunity to thank everyone for their cooperation in scheduling and incorporating Service Bulletin 14371.

Although all affected aircraft have been updated there are still fourteen (14) spare units that need to have the SB incorporated. Unfortunately their locations are presently unknown to Pratt & Whitney Canada Corp. (P&WC). A list of the affected FCU's serial numbers is included in Table 1 on page 2 of this SIL.

Because of the possibility that a Pre SB14371 FCU could be installed as a spare/replacement unit, P&WC has issued a revision to the Engine Maintenance Manual. Adding a caution note, that when installing a replacement FCU, confirm that the FCU is in fact, a post SB14371 unit.
